#### SUSAN BLAIR TINGLE ROWLAND OF VIRGINIA AND KENTUCKY !

Mrs. JoAnn R. Rice of Orlando, FL, our indefatigable researcher of TINGLES, has done it again. The following two pages are taken from the Bible of the Western Rowland - Susan Blair Tingle Family, Nelson County, KY. They appeared in "Kentucky Ancestors", Vol. 26 - No. 3, Winter 1991 quarterly of the Kentucky Historical Society.

This bible record proves that Susan Blair Tingle Rowland was the daughter of William and Jane Tingle, born 16 Oct. 1806 in Morgantown, Monongalia County, VA (now W. VA). Long time readers of our newsletter will recall the 10-page article by Mrs. Rice in Vol. 4 - No. 2 Summer 1990 which identified George Edmund Tingle, a brother of the above Susan Blair, or Susannah B., as her name appears in the original Guardian Summons to court in 1812. The court record was brought to the attention of your editor back in 1976 by Mrs. Dolli Tingle Brackett, one of the founders of this newsletter. Once again it shows how clues do exist to prove old records - all it takes is perseverance and time. Plenty of time!

The first names of some of the Rowland's ten children show the Tingle family connection, particularly Delia Co?e Rowland, born 25 Jan. 1835. She was undoubtedly named for Susan's older sister, Delia M. Tingle, who married Dr. Gabriel E. Cox in Bardstown, Nelson County, KY in 1818. The Rowland-Tingle Family Bible has now provided the names of many hidden Tingle descendants. Thank you once again, Mrs. Rice.

### EDWARD M. TINGLE OF DELAWARE (1919-1992)

Edward M. Tingle of Selbyville, Sussex County, Delaware died on 24 Oct. 1992 at Salisbury General Hospital, Salisbury, Maryland. He was 73.

Known as Ed Tingle, he was a World War II veteran, having enlisted in 1940 to become part of the Anti-Aircraft Coast Artillery. A year later on Dec. 7, 1941, he was doing guard duty around the three-inch guns of his ship in Pearl Halbor when the Japanese struck.

Fifty years afterwards, he and his family were set to depart for Pearl Harbor once again, as he had done in 1972 and 1986. However, the trip had to be cancelled because his son-in-law was severely injured in an automobile accident a few weeks before departure.

Ed Tingle was very active in the Veterans of Foreign Wars, having served as Delaware State Commander. He was a charter member of the Ocean View, Del. Mason-Dixon Post. He and his wife, the former Kathryn Mae McCabe, owned a motor court in Selbyville.

In addition to his wife, he left twin children - a son, Edward McCabe Tingle and a daughter, Kathryn Mae Tingle Harcum, and one granddaughter. Ed Tingle was a great-grandson of Benjamin D. Tingle and his wife, Mary Holland, to whom a marriage license was issued on 19 Dec. 1835 at Snow Hill, Worcester County Md. The staff of 'Tingle Descendants' extends its sympathy to the family of Ed Tingle.

### MRS. HELEN NEEDHAM TINGLE ( -1954) OF NEW YORK CITY

The following obituary which appeared in the New York Times of 9 Dec. 1954 came to our attention through the courtesy of a reader, Ms. Elaine Mitchell of Lakewood, Ohio:

MRS. HELEN TINGLE DIES

Noted Interior Decorator Led Shop at Macy's for 11 Years

"Mrs. Helen Needham Tingle, noted interior decorator, died yesterday in New York Hospital after a long illness. She was the wife of A. Preston Tingle."

"Mrs. Tingle, who made her home at 383 Park Avenue, was born in New York and studied at the New York School of Fine and Applied Arts now called the Parsons School."

"She had been in charge of the Decorator's Shop at R.H. Macy & Co. from 1935 to 1946. After resigning from that post she had conducted her own business."

"Surviving also are her parents, Mr. and Mrs. Thomas J. Needham of Scarsdale, N.Y.; a brother, Thomas J. Needham, Jr., a State Department official in Calcutta, India, and a sister, Mrs. Susan Girard of Santa Fe, N.M."

The above obituary seems to solve the mystery of ASHER PRESTON TINGLE whose name appears in the 'Baptismal Records of Sound Methodist Church, Williamsville, Delaware'. He was born 29 July 1904 and baptized in 1905, the son of ASHER VERDEN TINGLE and his wife, MARY ELIZABETH ATKINS.

Vol. 2 - No. 3 (Spring 1989) of 'TINGLE DESCENDANTS' carried a story about this branch of the Tingles. Mrs. Margaret Tingle Wise had written to Elias Tingle, Jr. and said - "Preston Tingle married a girl in New York, I forget her name, no children." The letter was dated 8 Oct. 1978. Mrs. Wise may no longer be living, but if so, the above obituary gives her the answer.

### KENTUCKY CAVALIERS IN DIXIE

These are "Reminiscences of a Confederate Cavalryman" by George Dallas Mosgrove, published in 1957 by McGowat-Mercer Press, Inc., Jackson, TN.

They contain the muster rolls of the Fourth Kentucky Cavalry Regiment, nearly nine hundred strong, when fully organized at Salyersville, Magoffin County on 5 Oct. 1862. The following TINGLE names appear:

Company F, R. TINGLE. transferred to Company I, Captain John J. Marshall.
Captain Marshall was killed at Russell Court House, VA.

Company I, JAMES TINGLE, Second Sergeant
R. TINGLE, Third Corporal
ROLAND TINGLE, transferred to Colonel Hawkins
REUBEN TINGLE
J.A. TINGLE, transferred to Colonel Hawkins

To quote - "The companies were made up of men from the counties of Harrison, Bourbon, Pendleton, Kenton, Campbell, Boone, Grant, Gallatin, Owen, Henry, Carroll, Trimble and Oldham. Some were from Louisville, others from different parts of the State, and not a few from other States."

"The battle of Perryville, fought Oct. 8th was most desperate and bloody the bloodiest ever fought on Kentucky soil. The battle was brief. It
began at 2:30 o'clock and closed at 6 p.m. Of 25,000 men, the Federals
lost, in killed and wounded, probably 4,000. The Confederates lost, in
killed and wounded about 3,000 of the 15,000 men they had in the fight."

"General Braxton Bragg of the Confederates resolved to retreat from the State, overruling the counsel of Generals Humphrey Marshall and Kirby Smith, who declared that such a movement was not necessary. The Fourth Kentucky Cavalry, having been assigned to General Marshall's command, assisted in covering the retreat, marching in rear of the immense wagon train — said to be about thirty miles long."

Many of us have heard the old story about three TINGLE brothers moving south from Pennsylvania which is told in more than one family history. Where did they come from originally and where did they go? That answer has eluded all Tingle researchers, so far. With over 2,000 Tingle descendants identified since the advent of our newsletter in 1987, the three Tingle names mentioned above do not come to light.

We need help badly on this puzzle. Dear readers - please dig a little deeper and try to help Mrs. Lila or your editor.

## KINDLE (or KENDAL) TINGLE and LUCY REDMON TINGLE OF KENTUCKY

Mrs. JoAnn R. Rice of Orlando, FL has continued her relentless search for Tingles in Kentucky. The result is shown on the following nine pages of this newsletter. It concerns KINDLE (or KENDAL) TINGLE, his wife MARY LUCINDA (LUCY) REDMON, their eleven children and descendants.

The information was prepared for Mrs. Swan Tingle of San Jose, California, a new member of Tingle Descendants. Once again it proves the depth of Mrs. Rice's research. Tingles throughout America can be grateful for the myriad data she has developed. The long hidden history of Kentucky Tingles is now coming to light.

"The following information has come to me, from several sources, so I will identify the sources in the text, with names and addresses, etc., listed on the past page. Copies of some of the records are enclosed."

"There were several Tingle ancestors, who lived and died in the area of Maryland/Delaware, and several possible fathers of KINDLE TINGLE, and the other Tingles who migrated to Kentucky, between 1790 & 1810. Since those early forefathers have not been proved, at this point, I will begin with KINDLE TINGLE, B. 1774 in Maryland, and MARY LUCINDA REDMON TINGLE, (Lucy), B. 1777, in Maryland. (Birth places were taken from the records of MILDRED BAUGH CARR, as shown in the family records section of THE KENTUCKY HISTORICAL SOCIETY, and sent to me by ELMER BECKHAM TINGLE and VIOLET STALKER, KY. researcher."

"My earliest contact with KINDLE TINGLE records, was in the Kentucky Census Index of 1810 and 1820, at Henry County..., I was searching for my great-great-grandfather, NATHANIEL TINGLE, born 1795, in FAYETTE COUNTY, KY.,...I found Nathaniel, and several other Tingles who were strangers to me, at that time."

"From a Henry County Deed record, Bk. 5, p. 544, dated March, 1815, KINDLE TINGLE purchased 50 acres of land, on Mill Creek, for 5 Shillings, from FRANCIS REDMAN, (his father-in-law). The record also reads, "doth grant bargain sell and convey unto the said Kindle Tingle,"

his heirs for one certain tract or parcel of land containing fifty (50) acres on the waters of MILL CREEK on which he now lives Henry County being part of lott No. 3 in the division of ELI ADAMS 1000 acre preemption.".....The above quotation, probably explains why Kindle did not appear in the 1800 Census of Kentucky, along with LITTLETON, THOMAS, JASPER AND JOHN TINGLE. He and Lucy were living with the FRANCIS REDMAN family. Or, so it appears.

KINDLE AND LITTLETON TINGLE, were probably brothers. They continued to live very closely, as did their sons and daughters, for half a century, in Henry, Carroll, Trimble and Owen Counties of Kentucky. The 1830 Census of Henry County, KY., listed 10 Tingles on pages 316 and 317. With each couple having large families, they soon increased to 30 families and hundreds of children, by 1850.

KINDLE AND LUCY REDMON-REDMAN-REDMOND-TINGLE, were married, before 1796, probably in Maryland or Delaware. The exact date, has not been ascertained.

From Vol. 5, p.151 of the FAYETTE COUNTY RECORDS, of wills, FRANCIS REDMON of Fayette Co., KY. drew his last will and testament in December, 1816, and was probated in January Court, 1817. The will named only one Tingle, grandchild, ELIZABETH TINGLE, (b.ca.1798). Elizabeth Tingle, was the 2nd child of KINDLE AND LUCY REDMONTINGLE, and was about age 19, when she inherited her grandfather's bedroom furniture, after his death......It appears that Elizabeth was named after her grandmother, Elizabeth ( ) Redmon, but I wonder why she was the only one of the eleven mentioned in the will?

KINDLE TINGLE was one of several Tingle, men who served in the War of 1812, for Kentucky. He was already married, with 7 or 8 children, when he served his 60 to 90 days....In June of 1990, I sent a request to National Archives Trust Fund (NNMS), to locate the records for Kindle Tingle's Pension application. It was returned to me, marked, "NO..We were unable to locate the file you requested above." His Bounty-Land Warrant may be available, but I have not tried to locate that record, as yet.

A family record sheet, on file, in the Dept. of Library & Archives, at Frankfort, Ky., submitted by Mildred Baugh Carr, of Kentucky, states that Kindle & Lucy had 11 children, 7 sons and 4 daughters. I found an older female, living with Kindle & Lucy, in the 1810 Census, p. 367, of Henry County, KY. microfilm. She was age 16 to 25 years, making her birthdate about 1784 to 1794....I believe she may have been MALISSA TINGLE, who appeared in the 1850 census, age 68, born ca. 1782. She was listed with Kindle Tingle, jr. and some very young children....She was probably a maiden, sister of Kindle, sr., and the aunt of Kindle, jr....She was gone by 1860.

To the best of my knowledge, and a few others, the following persons, were the children of KINDLE & LUCY REDMON TINGLE, of KENTUCKY:

- 1. DANIEL TINGLE, b.ca. 1796, married 3 March, 1817, Henry Co., KY., to MARY CRITTENDEN. (A Daniel Tingle was in Indiana, in Dearborn County, Jackson TWP., p.127 of 1840 Census.)
  - 2. ELIZABETH TINGLE, b.ca. 1798, married 22 February, 1834, Henry Co., KY., to JACOB WHITE.

To Swan Tingle & Seeger William R. Tingle, who went to Ill. Jody R. See #5/

- 3... LEVIN R. TINGLE, OR LEVER R. TINGLE, born ca. 1800. Married MARY( ), ca.1818. They had 6 children by the 1830 census of Henry County, KY.,p.316.... (May have gone to Indiana)
- 4...BENJAMIN J. TINGLE, born ca.1804, Fayette County, KY. and married SARAH (SALLY) DUGAN OR DOGAN, 13 August, 1829, Henry County, KY... The 1850 Census of Henry County, KY., p.377, listed the following children; <u>LORINDA TINGLE</u> (or Dorinda)b. ca. 1831, was age 19. (She died at age 24, on 16 May, 1855, near Port Royal, Henry Co., KY.); .. WILLIAM TINGLE, 18 year old, male, born ca. 1832, Port Royal, Henry Co., KY.; ... CHARLES TINGLE, 14 year old, male, born ca. 1836, near Port Royal, KY. in Henry County, KY.;...LUCY ANN TINGLE, 12 year old female, born ca. 1838, near Port Royal, Henry County, KY.;...MARTHA TINGLE, 10 year old female, born ca. 1840, near Port Royal, Henry County, KY.;...JOHN S.TINGLE, 8 year old male, born ca. 1842, near Port Royal, Henry Co., KY.;...MARY J. TINGLE, 6 year old female, born ca. 1844, near Port Royal, Henry Co., KY.;... SARAH F. TINGLE, 3 year old female, born ca. 1847, near Port Royal, Henry Co., KY. (Sarah was checked as being either blind, deaf, or insane, on the 1850 Census enumerations.);...BENJAMIN TINGLE, JR., born January, 1850, was only 6 months old, at the time the 1850 census was being taken. (This child apparently died before 1860)..... A Benjamin Tingle, was listed in the 1860 census index of Decatur County, Indiana, but I have not, as yet, tried to find it..... This family seems to have moved to Indiana, between 1850 and 1860. (Some of the above info, was sent to me by Violet M. Stalker, of Kentucky)

Now, to get back to GEORGE W. TINGLE, b. ca. 1806, Fayette Co., KY. and his wife, CYNTHIA YOUNG, born ca. 1815, in Kentucky. This couple, had at least 7 children, as follows;... ELIZA JANE TINGLE, b.ca.1830, Ky., marr. JOSEPH LEPOINT, 13 June, 1848, Henry Co., KY.;... MARGARET TINGLE, b.ca. 1831-32, Ky., marr. CHARLES SIMPSON, 16 May, 1850, Henry Co., KY.;... MARY TINGLE, b.ca.1834;... JOSEPH T. TINGLE, b.1837, in Kentucky, married REBECCA GOODWIN, also born in Kentucky. Joseph & Rebecca Goodwin Tingle, must have moved to Ripley County, Indiana, sometime before their son, GEORGE WASHINGTON TINGLE was born, on 9 October, 1861, in that county......From an application for marriage license, issued 6 December, 1924, No.574, for GEORGE WASHING-TON TINGLE and ELLEN SHAW GLASS, Marion County, Indiana, Bk.124. George W. Tingle was a Furniture worker, and lived at 817 W. New York St., Indianapolis, Indiana. (Probably a Hotel, or rooming house, at that time and place.) He had been married twice before.

His first wife had died and the second marriage ended in divorce. No names were given.... ELLEN SHAW GLASS, was born 6 Sept., 1868, no place given. Her first husband had died on 7 May, 1924. She was also living at 817 W. New York St., Indianapolis, Indiana. Her occupation was given as Housework ... . At the time of her first husband's death, she was living at Clees?, Ohio...Her parents were JOHN CALVIN SHAW, born in Kentucky, with residence in Burksville, KY., and he was a farmer....Her mother was SARAH ANDERSON, born in Kentucky, with residence at Burksville, KY. She was a housewife. Each of these applicants signed their application with an X......I went into detail on this one, because I think it is possible and probable, that JOSEPH T. TINGLE and REBECCA GOODWIN TINGLE, named their son GEORGE WASHINGTON TINGLE, after Joseph's father, GEORGE W.(?) TINGLE, the son of KINDLE AND LUCY REDMON TINGLE No!

- 6.. JEPTHA LLOYD TINGLE, born ca. 1807, Henry County, Kentucky, married on 1 March, 1841, Henry County, Kentucky, to #1..MARY ANN MEEK or MEEKS. Mary Ann died young...Jeptha Lloyd then married SERENA MEEKS, who was probably the younger, sister of Mary Ann.....J. LLOYD TINGLE, died ca. 1851.....Serena then moved to Illinois, taking all of the children with her..... (Please refer to the records submitted by <u>JULIE RADFORD HARPER</u>, in Vol. 5, No.1, p.7, and Vol. 5, No. 3, pp.1-8. of our Tingle Descendants newsletter.)
- 7... KINDLE OR KENDAL TINGLE, JR., born ca. 1810, Henry County, KY., married #1 (? ),...#2..MARY GULLION, on 27 May, 1851, Carroll County, KY...His first wife probably died, before 1850, as there was a MALISSA TINGLE, age 68, living in the same household, and keeping house, and most likely caring for the two, young child-ren, <u>SARAH TINGLE</u>, and <u>JOHN TINGLE</u>, the children of Kindle, jr's first wife....By 1860, Malissa Tingle was gone, and <u>MARY GULL</u>-ION TINGLE was the mother of three of her own children; JAMES W. TINGLE; GEORGE S. TINGLE and CLARENDA TINGLE. Also living with the above mentioned family, in 1860 Census of Carroll Co., KY., p. 132 of the microfilm, was a 72 year old female, named SARAH GUILLION, born in Virginia. I am assuming that she was Mary's mother. The above mentioned MARY GULLION TINGLE, was Mary's mother. The above mentioned MARY GULLION TINGLE, was born ca.1813, Kentucky. (The above marriage date, was taken from the Carroll County Marriage Index Record, sent to me by Elmer Beckham Tingle. The census records were found in the Genealogy Dept. of the Orlando Public Library, from their microfilm collection.)
  - 8...Unknown Female, born ca. 1812, Henry County, Kentucky.
    9...Unknown Female, born ca. 1814, " "
  - 10. See Charles Tingle, below.
    - 11..Unknown Female, born ca. 1818, " "
  - \*10...CHARLES TINGLE, born ca. 1816, Henry County, KY., married to NANCY SKIDMORE MC GUIRE, on 12 January, 1835, Henry County, KY. Nancy is said, to have been the widow of AARON MC GUIRE..... Another Aaron Mc Guire was bondsman, for Nancy's marriage to Charles Tingle. Perhaps he was Aaron Mc Guire, jr ...... Charles and Nancy had at least 7 children, as listed below.
    - \* Nancy's parents, were WILLIAM SKIDMORE & MARY CRISWELL, both born ca. 1764-1784. Mary was born in Virginia. They married 23 June, 1792.\* (from family records of BETTY ANN BOWLES)

Names were copied from the 1850 Census of Carroll County, Kentucky, p. 167 of the microfilm, at Orlando Public Library, Genealogy Dept., Orlando, Florida;.....

1 (?)...MARY J. TINGLE, age not clear, but could be 13 or 19, female, white, born in Kentucky. Her birthdate would have been 1837 or 1831. She was probably 13 years old, if she was a daughter, since her parents were wed in 1835. (The microfilm was streaked, through the area of the ages of each family member, making it very difficult to make-out the numbers.) I have no further information about Mary J. Tingle.

- 2... ELIZABETH TINGLE, (born ca. 1835) was age 15, on the census of 1850, a white, female, born in Kentucky. From other records, she was born in Henry County, KY. She married MATHEW KEPHART, ca. 1855, Carroll or Trimble Co., KY. (This information was shown on a family group sheet, sent to me by Violet M. Stalker, and Elmer Beckham Tingle, from the family records section of the State Archives, at Frankfort, Ky.).. So far, I have not , found this marriage listed in any Kentucky Marriage Index.
- 3... JEPTHA LLOYD TINGLE, was 14 years old, white, male, not going to school. His father was a farmer, so Jeptha Lloyd was probably helping on the farm.....Family and marriage records tell us, that he was born 28 January, 1836, Carroll Co., KY. He married MARY F. JACOBY, on 20 October, 1859, Trimble Co., KY. He died on 9 November, 1893, in Trimble Co., KY..... This couple had 7 known children. (This is the line of ELMER BECKHAM TINGLE & several others, now members of 'Tingle Descendants') Please refer to Vol. 4, No.3, Spring Issue, 1991, of the newsletter, for Elmer's personal, family charts, showing his descent from KINDLE & LUCY REDMON TINGLE, to CHARLES & NANCY SKIDMORE MC-GUIRE TINGLE, to JEPTHA LLOYD & MARY FRANCES JACOBY TINGLE, to CHARLES WM. & NANCYE BEATRICE TROXELL TINGLE, to the present..... Elmer and other members of his family, have extensive records, on family group sheets, listing all descendants, save a baby or two, born since 1990. Their family should be a seperate writing.

4... NANCY ANN TINGLE, was age 11, born in Kentucky, white, female, attending school, on the 1850 Census enumeration..... Other family records from the Kentucky Archives, tell us that she was born August, 1839, Carroll County, Ky. She first marr. JOHN TINGLE, 23 August, 1854.... (As per Carroll County, Ky., Marriage records) ....John appears to be one of a set of twins, born ca. 1831, in Henry County, KY., to ZADOCK & LUDELL MALIN TINGLE., (As shown in the 1850 Census of Henry Co., KY., p382 of the microfilm.) His twin brother was TAMES TRUET. the microfilm.) His twin brother, was <u>JAMES TINGLE</u>. Both boys were age 19 years, and they were two of the 10 children listed. I don't know, for certain, the parents of <u>ZADOCK TINGLE</u>, but I have several reasons to believe that they were-LITTLETON TINGLE and SUSAN COBLIN TINGLE ..... At least, we know that Nancy Ann and John Tingle were some kind of cousins.....They had at least two children, before 1860. They were: MARY TINGLE, born ca. 1855, and MARGARET TINGLE, born ca. 1857...The family soon left Kentucky, to settle in Decatur County, Indiana, where John was killed, by a falling tree, while clearing land to farm on .... Nancy and the girls moved back to Kentucky, and she then married ELISHA WILLIAMS, who was born October, 1814, Henry Co., KY. He was 58 years old, and Nancy Ann was 29, when

5...CHARLES SAMUEL TINGLE, born ca., 1841, Carroll Co., KY., and married MARY ALICE LANE, in 1871, on 7 December, at Trimble County, Kentucky. (In the 1850 Census of Carroll Co., KY., p. 167, he was 9 years old, white, male and going to school.) Charles Samuel and Mary Alice Lane Tingle, had at least 5 children. A female child was born on 10 September, 1874, at Trimble Co., KY.; ...WILLIAM TINGLE, born ca. 1877, Trimble Co., Kentucky, married LETHA LEE LAHUE, in 1899, Trimble Co., KY., and lived in Bedford, Kentucky..... The other children have not been identified. (The above information was sent to me, by Elmer B. Tingle, from family records.).... Cemetery records of Trimble Co., Ky., at I.O.O.F. Cemetery, on the East side of U.S. 421, Bedford, Ky., on p. 46, listed C.S. TINGLE, born 18 June, 1841- died 7 Oct., 1910. (at age 69) and his wife, MARY ALICE LANE TINGLE, 1849-1917. (at age 68) (Trimble Co., Ky., Cemetery Index, was also forwarded to me by Elmer.) WILLIAM AND LETHA LEE LAHUE TINGLE had at least one son. named LEONARD MOUNT TINGLE, born 1912, Trimble Co., KY. He married SYLVIA COLBERT, and lived in Louisville, KY., where their son, LEONARD E. TINGLE, was born in 1945, and is the husband of VONNELL TINGLE. Leonard and Vonnell Tingle, are also members of our 'TINGLE DESCENDANTS' group, and compiled some of the above information...For more details about this line, I will leave it with them......From the I.O.O.F. CEMETERY, Bedford, KY., records, the following dates were shown for; WILLIAM R. TINGLE, 28 January, 1877-21 June, 1926.

- 7...WILLIAM B. TINGLE, born ca. 1847, Carroll County, KY., was only 3 years old, at the time of the 1850 Census of Carroll Co., Kentucky, p. 167.....William later married CLARA WHITAKER, 24 Jan., 1881, Carroll Co., KY.....From Mrs. Swan Tingle, I learned that her father in-law was ALBERT DELMAR ALEXANDER TINGLE, the son of William B. and Clara Whitaker Tingle, and that the family was said to be from Georgia...... I look forward to learning much more about Swan's and her husband's family....I was so excited over the phone call from Swan, I forgot to ask her what her husband's name was: Please stay tuned:
  - 8...HENRY MONNAVILLE or MONTRIVILLE TINGLE, was just 8 months old, when the 1850 Census was being recorded, in Carroll Co., KY., on p.167, of the microfilm, making his birth year, 1847, Carroll Co., KY. Henry M. Tingle married AMANDA WHITAKER, on 14 January, 1875, Trimble County, KY. (Amanda was probably the sister of Clara Whitaker, above.). Another record of marriages, Trimble Co., KY., shows HENRY C. TINGLE, marr. ARTEMITA WHITAKER, on 14 Jan., 1874. He was 24 years old and she was 18, making their birthdays in 1850 and 1856.... A Bethel Methodist Cemetery record, shows the same HENRY C. TINGLE, born 17 September, 1850, died 1 October, 1888.(age 38) Also listed, in the same Bethel Cem. records, was CHARLES TINGLE, born 9 July, 1876, Trimble County, KY., son of HENRY and MINTIE WHITAKER TINGLE.... A daughter, named SOPHA TINGLE, born on 7 Sept., 1881, died on 1 Sept., 1882. She had died just one week before her first birthday...It appears that Henry Monnaville and Henry C. Tingle might have been the same man.....Another example of how poorly spelled or recorded, were some of the names, in early records......
- ?....On the same page of the 1850 Census enumeration, living in the same household, were the following persons;

PAULINA SKIDMORE, 22 year old female, did not read or write.

MELVINA " 5 year old female.

ELIJAH A. " 2 year old male.

Paulina was shown as the 165th family, but under the 159th residence, with Charles and Nancy & family. They could have been the younger sisters and brother of Nancy, or a sisterin-law, with her two children.

There were three adults in the above household, with 10 children to raise, yet none of the adults could read or write.

P.S... The Cemetery Records, mentioned above, for Henry County, plus some bordering counties, is a 16 page listing, of many old Cemeteries, including a map, with corresponding numbers, to identify each cemetery by place and name. All the Tingles are listed in alphabetical order, with numbers given, to find the cemeteries and location of same.....Family relationships may be proven, by matching the lot numbers and cemetery numbers. However, it is time consuming, to say the least ... However, I was overjoyed to receive the record copies, from Elmer B. Tingle,

and have been spending as much time as possible, matching the parents with children.... The map I mentioned above, also shows locations by degrees, as well as roads, etc.... In the center of the eastern part of Henry County, KY., a few miles north of Franklinton, KY., and south of Bullitt Hill Road, beginning at highway 360, commencing west, is a short, crooked road, named TINGLE RD.....Obviously named that, because Tingles once lived there, or perhaps still do....I have a hunch that there may be a family cemetery, on the farm, on Tingle Road, just waiting to be discovered. The markers, if they had any, may now be overgrown, or even used for stepping stones, somewhere.... The legend of the above mentioned map, was not with the map, so I'm not sure what kind of road, Tingle Rd. is, but the bigger roads seem to be in a solid, black, line, while the small ones are in black and white, alternate patterns. My guess is, that Tingle Rd. is a blacktop road, now....If I ever drive through Kentucky again, I plan to go exploring, if it is legal. (I have enclosed a copy of the map.).... If you or anyone else, would like copies of the cemeteries and Tingles who are buried in them, let me know, and I will send copies. PERHAPS ELMER KNOWS ABOUT TINGLE RD., OR WILL GO EXPLORING FOR US????? Elmer later looked for Tingle Rd. but it does not now lifet, as of 1995. J.R.

p.148, Examination of the accounts of JAMES DAWSON, Administrator for the estate of WILLIAM DAWSON, dec'd, by ABNER WILSON, MARTIN MOORE and RICHARD MITCHELL, Commissioners. Recorded December Court 1816.

p.149, Survey of the lands of DAVID BIBB, dec'd, and allotment to ANN BIBB, widow, her rights of dower. This being completed, a bargain and sale took place between the heirs of the said decedent which rendered it unnecessary to proceed any further. Survey by WILLIAM COTTON, Deputy Survey for JOHN PRICE, Surveyor, with GEORGE MURE and BAILEY BENTLEY, chain carriers. Commissioners, AMBROSE YOUNG, JAMES BENTLEY and WILLIAM CURRY. Recorded December Court 1816.

p.150, Will of JAMES WARDLOW, SR. declares that he gave "to every child when they left me what I thought was their proportion of what I then possessed, and as a great part of what I now have has not arisen from my labour, but by the industry of my sons, I therefore order and direct that what I now have and not otherwise disposed of" go to two sons JOHN WARDLOW and JAMES WARDLOW to be equally divided between them. Executors to receive all debts due testator, and to pay all just demands against him. To three grandchildren ANDERSON MCPHEETERS, PEGGY MCPHEETERS and MARTHA—MCPHEETERS, one negro woman named Peg, with all her increase, to be equally divided between them. Testator's religious books brought from Virginia are to be equally divided among testator's four sons and daughter. Executors to provide and give every grandchild the testator has a pocket Bible. [Not dated.] NATHANIEL FERGUSON and JAMES MARTIN, witnesses. Probated January Court 1817.

p.151, Will of FRANCIS REDMON of Fayette County gives to beloved wife ELIZABETH REDMON the bed and furniture which she for herself makes use of at this time, also a large iton-bound trunk, to be disposed of as may think proper. To daughter FRANCES REDMON \$20.00, to be paid to her at the time testator's wife dies. To granddaughter ELIZABETH TINGLE, the bed and furniture "on which I now lay." To JOSEPH REDMON, son of Joseph, all the wearing apparel of whatever kind or nature. All the residue of the estate is to be sold at public auction on a credit of twelve months, and all the money arising therefrom, together with money now on hand, to be put out to interest and the said interest to apply to the support of testator's wife in any way she may think proper. After wife dies, the money put out to interest, except the \$20 bequeathed to daughter Frances Redmon, is to be equally divided between two grandsons JOHN REDMON, son of CHARLES REDMON, and Francis Redmon, son of John Redmon. Appoints two sons Charles Redmon and John Redmon as executors. December 16, 1816. ROBERT WILSON, JOSEPH J. WILSON and JOHN GRAVES, witnesses. Probated January Court 1817.
